### Entry Fee

\$25.00 (includes Oktoberfest entry tickets for two (2) race handlers, use of Dachshund bun costume, and 1 t-shirt)

Each Dachshund will have their provided hot dog bun costume, and will run approximately 75 ft. from one handler to the other handler at the finish line. The winner of each heat will compete in a final race to determine the winning wiener! Prizes will be awarded to the top 1st, 2nd, and 3rd place finishers.

**Participation will be limited to the first 50 registrants** who deliver their completed entry form, proof of rabies vaccination, and entry fee to either the HOTO Sertoma Club office (address noted below) or at the site of the race by 6:00 p.m. However, **advance registration is encouraged.**

### CONTEST RULES

- **Current rabies vaccination record (rabies certificate from a veterinarian) must be presented at time of check in.**
- **Two (2) race handlers (provided by entrant) are required for each Dachshund dog entry.**
- **Keep your dog on a 6 ft. or shorter leash at all times, except when racing.**
- **Handlers and owners will be responsible for cleaning up after their dog.**
- **Dogs must be socialized with other dogs and people.**
- **Dogs in heat should be left at home**
- **Children under 16 years of age must be accompanied by an adult (18 years or older).**
- **Owners must remove their dog and leave the race if their dog acts aggressively towards people, other dogs, poses a safety risk to others, or appears to be unhealthy.**
